Census Deadline Moved Up to September 30th

More than four in every ten North Carolina households have not yet filled out the 2020 Census, representing more than 4 million North Carolinians not currently captured in the Census.

A Census response brings \$1,823 per person, per year in federal and state funds back to N.C. counties and towns.

That's \$18,230 over the decade.

For a family of five, that's \$91,150.

For a neighborhood of 150, that's \$2,734,000.

That's why it is so vitally important to complete the Census. Take five minutes and visit <u>my2020census.gov</u>, mail in the questionnaire you received earlier this year, or phone 844-330-2020.

Every response counts.






Johnston County Schools Curbside Meal Information

The Johnston County Public Schools nutrition staff served *more than 4,000 meals to students in remote learning on Monday*! The lunch service time is 11:00am-12:00 pm Monday through Friday. Students in all grade levels can receive meals curbside and when coming through our lines will be given one lunch and one breakfast meal at no cost.

Beginning September 1, students or parents picking up meals curbside will be asked to give their child's name or lunch number. Parents are encouraged to complete our Meal Applications at www.lunchapplication.com for assistance with paying for their child's meal. Children can use the same meal status from last school year for the first 30 days of school and that grace period ends on September 28. After that date students' meals will either be free or paid, depending on their status for this school year. The price for a paid student lunch in K-8 is \$2.30, and the price for 9-12 is \$2.40.

Governor Extends "Phase Two" Through September 11th, Continues Face Covering Mandate

Governor Roy Cooper announced the extension of "Phase Two" of COVID-19 restrictions until **September 11th at 5pm**. Additionally, face covering mandates remain in place, requiring them in retail businesses, restaurants (when customers are not at their table), personal care

and grooming businesses, child care facilities, long-term care facilities and more.

--- You can still make payments at Town Hall but will do so via a speaker placed in our vestibule at the rear of the building. For additional safety, we are only allowing one person at a time inside the vestibule.

Please maintain appropriate social distancing outside Town Hall; lines are in place on the walkway for assistance.

The following payment options are available:

- 1. Pay online at <u>www.smithfield-nc.com</u>. Click on the "Pay Utility" icon on the homepage.
- 2. Call 1-855-603-9197 (debit/credit payments only).

3. Place your payment in one of the two drop boxes outside, either the drop box attached to the building OR in the parking lot. If you are paying with CASH, we ask that you please use the drop box attached to the building. (No change will be given; anything over the amount due will be applied to next month's bill)

Payments received in either drop box before 5pm will be processed for the date the payment was received.
