Early Voting Sites Open in North Carolina

As of this morning, from Manteo to Murphy and every big city and small town in between, voting sites are open across North Carolina.

Set against the backdrop of a beautiful fall morning here in downtown Smithfield, our picture was taken approximately one hour into the early voting period and we estimate there were around 150 people in line. What an impressive site to see!

Here in Smithfield, early voting is held at the First Baptist Church Ministry Center at 125 S. Fourth Street. Voting hours are Monday - Friday 7:30 am to 7:30 pm, Saturday, October 17th and 24th from 7:30 am to 5:30 pm, and Saturday October 31st from 8:00 am to 3:00 pm.

The Town of Smithfield has approved the hours of 5-8pm on Saturday, October 31 to celebrate Halloween. Events such as haunted houses, trunk-or-treats, fall

festivals, etc. are discouraged.

Residents who wish to participate are asked to distribute candies that are either wrapped or bagged instead of handing out individual pieces at a time; homemade candies and goodies are not recommended. Residents are also encouraged not to use a "community bowl" to pass out candy; rather, set out candies on a table at an appropriate distance away from the door for children to help themselves.

Those residents who do not wish to participate in trick-or-treating are asked to leave their outdoor lights off during the approved Halloween hours.
